ROLES AND RESPONSIBILITIES OF ANTIRAGGING SQUAD MEMBERS

- As per the UGC guidelines (*Regulations on Curbing the Menace of Ragging in Higher Education, Gazette of India dated July 4, 2009*)¹, every Institute shall constitute a smaller body in addition to the Anti Ragging Committee, known as "**Anti-Ragging Squad**", nominated by the Head of the Institution.
- This body will have only internal members and the purpose of this body is for **maintaining vigil, oversight and for carrying on patrolling functions**. The members of the Squad must remain mobile, alert and active at all times.
- Further, it shall be the duty of the Anti-Ragging Squad, to make **surprise raids** on hostels, and other places vulnerable to incidents and having potential for ragging and shall be empowered to inspect such places as and when they suspect or as and when the Principal requests them to do so.
- It shall also be the duty of the Anti-Ragging Squad to conduct an on the spot **preliminary enquiry** in to any incident of ragging referred by the Principal or any other member faculty, the staff or any student or parent or any other person who report such incidents.
- The **enquiry report along with recommendations** shall be submitted to the Anti-Ragging Squad Committee for action under clause (a) of Regulation 9.1. Provided that the Anti-Ragging Squad shall conduct such enquiry observing a fair and transparent procedure and the principles of natural justice and after giving adequate opportunity to the student or students accused of ragging and other witnesses to place before it the facts, documents and views concerning the incident.
