1. Minutes were confirmed by all IQAC Members.
2. Efforts taken by the College for Online Education and Assessment / Examination were conveyed and discussed with IQAC Members. The efforts are as follows:
 - MASTERSOFT ERP and Subscription of MICROSOFT TEAMS PLATFORM for conducting lectures and Practicals.
 - Microsoft Teams engage students with virtual face-to-face connection and activities. It offers effective learning, all in one place. Students, teaching and non-teaching staff meet, create content and share resources in Office 365 education - featuring the simple intuitive power of Microsoft.
 - Microsoft teams helps to collaborate with ease, engage learners and elevate day-to-day work. Some of the features that educators can use to engage the learners are listed below: Assignments - MCQ based or Subjective, Screen Sharing, Immersive screen reader, Whiteboard, Raise your hand, Together mode, Accessibility, LMS, integration, Team of type class creation, Class Notebook, Chat, Grades.

 - d. Guidelines for preparing Question Bank mapping to COs and Revised Bloom's Taxonomy have been communicated to all the Departments.
 - e. Several Orientation / Training Programmes for all Departments were extensively conducted by IQAC to understand OBE Module.

5. Policies and SOPs: Policies and SOPs were discussed and placed for approval in the meeting. (Research Policy, Policy for Consultancy, SOP for applying and obtaining for Research, Environmental Policy, Ethics Research, Green Initiatives, Industry Institute Interaction Cell, Maintenance Policy, Mentoring, Plagiarism, Placement, Policy for Feedback on Teaching-Learning, SOP for Purchases, SOP for Alumni Registration Process and Sports Policy).
6. Diagnostic Test for identifying slow and advance learners: As suggested by the experts during the Academic and Administrative Audit, Diagnostic Test was implemented for all PG Programmes. The Guidelines for conducting Diagnostic Test were written down by the IQAC and circulated to the respective PG Coordinators. Based on the Diagnostic Test, the Teaching-Learning Process needs to be modified as per the requirement of the present class.
7. Mentoring Mechanism implemented in the College: The process / mechanism of Mentoring has been well defined and implemented in the College for all academic programmes. A brief presentation regarding the process and making it online was discussed and approved in the meeting. A Mentoring Team has been formed to support Teacher-Mentors and receive inputs from them to improve the system.
8. Revisions in Feedback Formats on Teaching-Learning and Curricula:

Revisions have been made in Feedback Format for Teaching-Learning by including Online Education and effectiveness of Online Education in the Format. In the Feedback Format on Curriculum, Course outcomes stated and its relevance to the course content has been included. The Formats were approved by all IQAC Members.

9. MoUs and IQAC Collaborative Initiatives:

IQAC has facilitation continuation of MoUs for NGOs - Seva Sahayog Foundation, Muse Club, Welfare Association of Youth - Project Aasra. Apart from this, the IQAC has facilitation MoU with Department of Physics, Rajaram College, Kolhapur (Government of Maharashtra) and Department of Physics, Bajaj College of Science (Autonomous), Wardha. Further, IQAC has collaborated with Vivekanand College (Autonomous), Kolhapur for IQAC Initiatives between two Colleges. The College has entered into collaboration with Jagiellonian University in Krakow (Poland) and signed 'Inter-Institutional Agreement 2021 - 2023' under Erasmus Plus Programme.

Orientation Programmes for all Teaching Staff for Schemes like UGC-SPARC Programme, ISRO Funding Programmes and UGC-STRIDE (Component-II) was conducted by Research Co-ordination Committee (RCC). Special Lectures / Webinars in Specific Research Areas like Scanning Electron Microscopy, Optical Absorption Spectroscopy, 'Atom Probe Tomography (APT)', 'Electrical Mobility and New Technology' were conducted. Teaching Staff was also motivated to publish in UGC-CARE listed Journals.

12. Placements and Industries:

Overview of Pre-Placement and Placement Activities was presented. Special Efforts in the form of ten different lectures / interactions to create awareness IPR / Patents have been facilitated by Career Facilitation Centre. (CFC).

13. Overview of Social Outreach Activities and SAATHI Enabling Center:

The SOEC has conducted Orientation Programme on Poster Exhibition and Themes like Gender Atrocities, Inequality in Profession, Gender Fluidity, Socially Accepted Gender roles and the Transgender Bill. Apart from that, SOEC also has collaborated with different NGOs and our students have volunteered / participated in social activities of these NGOs. A remarkable activity of audio recording of books was undertaken by our college students and this activity was called as 'Let's record activity.' This activity has received a huge response from the students as well as the society and it has created a new platform for learning for visually challenged students of our college.

The progress of preparation of 4th Cycle of Assessment and Accreditation by NAAC is as follows:


- i. Formation of a NAAC Core Team and distribution of Criterion groupwise.

The meeting was conducted at the IQAC to discuss the plan for mentoring in the year 2021-2022.


The following are points were discussed:
